Angel County Forest Service Volunteer Fire Watch Requirements

1. Applications shall be completed in full using the current recruit application form available by contacting Acting Chief Woodford at chief@acfs.ca or by calling 555-0147 for the dispatch. Applications can also be picked up at the Angel County Forest Station located at just outside of Signal Ridge and Angel County.
2. Each application shall have the following documents attached.
 - a. Personal Resume
 - b. A photocopy of current valid Provincial Drivers License (front and back)
 - c. Provide a copy of High School Diploma or equivalent
3. Upon acceptance of the application form, all applicants will be required to complete the following
 - a. Attend an information session, facilitated by the Office of the Forest Chief
 - b. Complete a basic Fire Watch task related physical assessment as will be outlined in the information session
 - c. Attend a personal interview with the Chief and Officers of the Angel County Forest Service
 - d. Provide a current drivers abstract from Motor Vehicle Registration of Signal Ridge or surrounding counties.
 - e. Provide a certificate of conduct from the Government of Angel County, or Trudy.
 - f. Must have 24/7 access to a motor vehicle for emergency call response
 - g. Successful completion of a 3-month training program consisting of Defensive Fire Watch Course and Advanced First Aid Course. (Covered during Thursday night training sessions/one weekend)
 - h. All Recruits will be subject to completion of a one-year probationary period
 - i. Obtain medical consent from a physician to be cleared for Fire Watch duties
